# **KNOW THY (NEW!) NEIGHBOR: MEET THE MOSELYS**



#### **NEW STORM DRAIN LABELING A SUCCESS**

Only rain in our neighborhood drains, thanks to the efforts of the Hillbrook-Tall Oaks Civic Association Drain Labeling Expeditionary Force (HTOCADLEF) this summer.

You may have noticed the new labels around the neighborhood. A cadre of volunteers clad in orange reflective vests and handling very sticky glue (really, don't test just how sticky it is!) replaced or labeled more than 60 stormwater drains in the neighborhood.

These labels have a shad fish to remind us that what goes in the drains goes directly to our local streams, then to the Potomac River and then on to the Chesapeake Bay.

The water in a storm drain does not go to a treatment plant, so nothing is removed from the water. That means pet waste, yard debris, fertilizer, motor oil, pesticides and trash all have the potential to flow into our streams and the Chesapeake Bay.



Pollution that enters our water through the storm drains is called non-point source pollution because it comes from all our homes and communities - many diffuse sources, not a single "point" source. Non-point source pollution is the leading cause of water quality deterioration in the Chesapeake Bay.

For this project, we partnered with the Northern Virginia Soil and Water Conservation District, which provided training, supplies and support. Check out the website for lots of interesting information: https://www.fairfaxcounty.gov/soil-water-conservation/.

#### LIGHT-EMITTING DIODE STREET LIGHTS INSTALLED

**Does your street seem a little brighter at night lately?** It should. In the past two months Fairfax County had Dominion Energy, Inc., the provider of electricity to Hillbrook-Tall Oaks, replace all of the existing streetlights (either Mercury-Vapor or High-Pressure Sodium) with light-emitting diode (LED) bulb units. The county made the switch to the lower power-consuming LED street lighting to reduce streetlighting costs.

Fairfax County chose to install LED bulbs that have a lumen output that is approximately 30 percent greater than the bulbs they replace. In addition, these bulbs do not have diffusers that restrict the range of lighting flare generated by the bulbs. Consequently, many residences will see deeper light penetration in their yards, an outcome that some people may like, and others may not like. For houses with bedrooms that front on a street, the level of darkness in the bedroom may be reduced due to the increased lumen output and lack of lighting flare control.

So what can be done if you find your yard and bedroom to be too bright? There is a solution to confine the LED flare and thereby reduce the amount of light hitting your property a residence. Upon request, Dominion Energy contractors can install at no charge to residents a finned bracket on the streetlight that can steer light away from your yard. The device seems fairly effective at holding light to the street and limiting leakage into yards.

As for the impact of LED streetlighting on wildlife on Hillbrook-Tall Oaks, it is uncertain. Some scientific literature suggests that some species of birds, bats, turtles, and other wildlife could be affected.

Fugitive light-controlling brackets for lighting units are installed on a pole-by-pole basis. Go to the power pole(s) in your yard or across the street from your yard where you want light dispersion limited – and copy the 9-character (letters and numbers) identification code on each pole (see photo below for an example). 

#### **NEW GROUP HOME SERVES TROUBLED YOUTHS**

A group home for youths opened in early August at 4700 Monterey Drive. The Discovery Mood and Anxiety Programs center provides mental health, substance use, and eating disorder treatments for youths ages 11-17. Staff are present 24/7 but do not live there. The Annandale center is licensed for up to eight residents, says Sandra Sellani, spokesperson for Discovery Behavioral Health Inc., a healthcare company that operates more than 100 treatment centers nationwide. According to Sellani, a home-like setting "creates an environment that is conducive to recovery and integration back into family life."

Discovery also operates a residential treatment facility in Fairfax Station and is opening a new one in Fairfax. The facilities specialize in "evidence-based treatment, such as dialectical behavior therapy, cognitive behavioral therapy, acceptance commitment therapy, and other modalities to create a comprehensive, personalized treatment plan for each patient," says Amy Brown, president of Discovery's Mental Health Division. The program also includes experiential activities, such as creative art expression, music, and meditation. Patients have a multidisciplinary treatment team that provides medication management and education by a board-certified psychiatrist, individual therapy, family therapy, and psycho-education groups.

"The COVID-19 pandemic has caused the nation to experience an unprecedented level of stress and anxiety about the health of ourselves and our loved ones," says Discovery Behavioral Health President John Peloquin. "Those already suffering from mental illness are facing even greater challenges. This is why we believe it is imperative to open our new mental health treatment centers, providing greater access to care for all of us enduring the current national health emergency."

# COUNTY'S PROPOSED REVISED LAND USE ZONING ORDINANCES (zMOD) RAISING CONCERNS

Since 2017, Fairfax County has been updating and modernizing its land use zoning ordinanc-

**es**. The intent is to make them more understandable and current. After conducting public input meetings, the proposed new land use zoning codes are ready for review by county land use planning committee and the Board of Supervisors, with public hearings to be scheduled. The schedule set a goal of this winter for completion and adoption.

One issue being addressed is a new approval process for giving homeowners the ability to add **accessory dwelling units (ADUs)** within their home. Currently, the process allows for an ADU that would include two bedrooms and a kitchen area for up to two elderly persons aged 55 and above, or persons with disabilities of any age. If a property is two or more acres, such units can be constructed as a separate structure on the property. In the past, these proposed additions required a public hearing and a special permitting approval to give neighborhoods an opportunity for input.

The proposed new ordinance addressing ADUs within a current home would make this an administrative permitting process without a public hearing process, while also eliminating the age or disability use qualifications. The intent is to create more affordable housing opportunities in Fairfax County. The public hearing and permitting requirement remain for detached ADUs.

This proposed new ADU process could have significant impacts on the character of single family neighborhoods. Some fear that it could create bordering house intrusions in single family neighborhoods. **The Mason District Council homeowners' association, which includes HTOCA, is opposing these proposed changes**. The council's letter to MDC members contains more details on this subject, which we can forward to any interested neighbors. The HTOCA board is monitoring these developments and may be engaging the community more about these proposed changes.

#### **NEIGHBOR HAS MADE 550 FACE MASKS**

Carol Schuttinga, who lives at 5020 Dodson Drive, has been busy making homemade masks that she makes available to neighbors. We thanked her for her efforts and asked what inspired her. Here's what Carol had to say:

"It's been my pleasure to be able to make masks and have them available to people who need them. It's actually been a blessing to have something to help fill my time in these last few unusual months.

"I have been sewing since my early teens. For about 25 years, I had a small craft business making scarves until I retired four years ago. Retirement left me with a good supply of elastic, which I had used in my scarves. And like most seamstresses, my fabric drawer was full.

"This left me well-prepared to sew masks, the first 50 in response to a request on NextDoor, which also gave me the instructions on how to make them. Another request came from a friend working in healthcare at a retirement community. Another request came from a business where masks were required and almost impossible to acquire. I realized that this was definitely a need!"

"Since then, I've given away masks to my family, my church family and the neighborhood. I've made a total of 550 to date."

#### **GLASS RECYCLING UPDATES**

As most of you may know, Fairfax County is no longer accepting glass as part of curbside recycling pickup. Options are to throw away glass in the trash, or collect and deliver it to glass recycling bins within the county. The closest location is at the Mason District Government Center at 6507 Columbia Pike, Annandale.
